### **Social & Solidarity Economy:**

a few central notions & cultural distinctions

- Sociationomy
  - French/latin speaking areas : "social" refers to the type of ownership by individual persons and not by shareholders, functioning on the principle of "one person, one vote".
  - Englishspeakingareas= "thirdsector : "social" relates to the purpose or the sector of activity (day-care, health, care of the elderly, etc.)




Associations, cooperatives, mutuals,a variety of non-profits as well as charities and foundations are included

- environmental sustainability


 $\rightarrow$  part of the Market economy and does not challenge it in a transformative way.

**Social intrepreneurship:** a social enterprise/entrepreneurship is related to "the creation of a social value that is produced in collaboration with people and organisations from the civil society who are engaged in social innovations that usually imply an economic activity". They are for-profit or non-profit organisations acting on a market and providers of welfare services, seeking social impact of their actions and activities, applying commercial strategies that include social value.



#### Solidarit **E**conomy

- transformative
- collectivejtizen-led initiatives
- understanding economy as a space of social relationships
- based on solidarity, human and Earth rights, self-determination, mutuality and cooperation.

Todemocratisæconomyand participattrengthening socialeconomicand environmentalistice.

#### Not a sector of the economy

 $\rightarrow$  transversal approach that includes initiatives in all sectors, sharing a broad set of values contrasting with the dominant Marketeconomy

Plural democracy must be linked to a plural economy

- Karl Polanyi and embedded economy (in social interactions)
- $\rightarrow$  substentive economy vs formal economy
- Eleonor Ostrom and the Commons

 $\rightarrow$  Understanding institutional diversity + Knowledge as a commons

Challenge to redefine economic activity as a human and social interaction consolidation of Representative + participatory + deliberative democracies human rights-based approach

> expression of collective needs and aspirations

#### **Social innovation =**

reconfiguration of public issues + the public nature of citizens' initiatives

renew democracy

> enrich public action

social transformation via inclusive solidarity

(≠ privilege the private sector)

- Civil society mobilized propeling a new economic culture and imagination
- Giving regional, European and international perspective to local actions



- Cross-cuting conversations & help interconnections
- New learnings/teaching/metodologies
